PG outlined the latest position with site operations. The site had made a significant loss in the previous year, mainly due to the parent company. The site will now revert to its core business ( mainly Toll work) There had been some redundancies.

SM gave SH details of where Essar could obtain the Environment Agency monitoring results from surface water ( not part of EP). SH said Essar are keen to review monitoring requirements. SM suggested they speak to Monitoring Officer (Carl Bethell).

SM discussed the FAR project and how Sector plans and Area intervention plans would become the way of working going forward. PG was keen that the metals sector plan be made available to Essar. SM also discussed COMAH work with HSE.
